President's Report Big Brothers Big Sisters of Yorkton and Area Annual General Meeting 2023

The year started with the completion of an office makeover, with new windows, flooring, paint and blinds creating a fresh atmosphere. We ended the year with the purchase of new computers. This was a needed upgrade as staff continue to transition to electronic filing.

In the summer I was able to attend the BBBS National Convention in Winnipeg along with our Executive Director. It was interesting to observe the larger organization and listen to the matters that they deal with and how it affects us. Since then, the National Board has been renewed and a new ED has been hired. Clarity of service, communication and sustainability is their immediate focus.

I represented the Agency at the Yorkton and District Community Foundation AGM where we received a donation from their annual disbursements. It was good to be recognized by them again. The Agency is a partner with the VTRA initiative, and I attended the signing ceremony. It was also fun to flip burgers at a fundraising car show at Staples and to help out with the Golf for Kids Sake in Esterhazy where we almost topped \$60,000 gross revenue.

Internally, we completed an annual self evaluation of the board, and I conducted the annual review of the Executive Director. We had a Child Safety and Organizational Health Audit by the National office whereby they confirmed we are exceeding National Standards. A Human Resource Committee was created late in the year but is already proving value in governance.

In the fall we had a weekend facilitated by Prairie Wild Consultants where we looked at our Strategic Plan for the next five years. This included staff and board and we considered our possibilities in the service area of Yorkton and the district. A report available to the public is forth coming.

Thank you again to Irma, our Executive Director, who represents us professionally at the local, provincial and national levels and with the Truth and Reconciliation initiative. Irma never loses sight of our purpose to benefit children.







ORGANIZATIONAL CHART








2022 Revenue \$303,371





The revenues are decreased in 2023 compared to 2022 due primarily to the decrease in federal and provincial grants and we saw an increase in fundraising which kept us to a slight deficit. We saw a slight decrease in expenditures in 2023 due to decreasing salary and fundraising expenses. Community Grants included: South Sask Community Foundation (Murray & Edna Forbes Foundation and Smart and Caring Fund), Sask Culture, Sask Lotteries and the Community Grant of Canada. Fundraising includes Bowl For Kids Sake (\$19485. net), Golf For Kids Sake (\$42393. net) plus a Show N Shine, Face painting, BBQ's and Bingo (\$12,475). Service Delivery includes Recreation/Education, transportation., promotion, and staff/board education. Thank you to all our sponsors and donors in 2023 that helped us continue to make a positive impact in a child's life through mentoring.

These mentoring relationships have proven to be transformative, providing young people with the guidance, support, and encouragement they need to thrive academically, socially, and emotionally.

Big Brothers Big Sisters of Yorkton and Area enables life-changing mentoring relationships to ignite the power and potential of young people, providing quality volunteer-based mentors. Our mentors teach by example the importance of giving and giving back, of staying in school and of having respect for family, peers and community. Mentoring is proven to improve children's odds for succeeding in school, increases self-esteem and self-worth, and the youth experience first-hand the importance of helping others in their community. Mentoring improves a youth's social emotional competence, mental health well-being and provides educational encouragement and employment readiness.

We have **formalized the mentor process** offering the best possible services by providing mentors for children and youth who need a significant, caring adult in their lives. These specialized services include creating **public awareness** of the values of mentoring; **group mentoring relationships** such as Catch the Dream Circle Project (Murray & Edna Forbes Grant), Kids 'N' Kops, Club Connect After School Programs, and our **site-based one-on-one mentoring relationships** such as In-School Mentoring and Teen Mentoring, and the **community based one-on-one mentoring relationships** such as Traditional Big Brothers Big Sisters, and Virtual Mentoring Program. Our Teen Mentoring Program engages youth and helps assist them develop their leadership skills and abilities to better themselves and their communities.

Here at Big Brothers Big Sisters of Yorkton and Area we are **committed to Truth and Reconciliation and the 94 Calls to Action.** We see the value of working with community partners and thus we helped to bring together a coalition of human service agencies and community partners for a Reconciliation Gatherings. We value the Indigenous Mentoring Guide we use for training.

We are grateful for all the funding received plus the many partnerships within the communities including provincial, federal and other community grants, many sponsors, participants, supporters and volunteers of our major special events including Golf For Kids' Sake, a Bowl For Kids' Sake and our annual Show N Shine at Walmart.

We are deeply appreciative of the media's steadfast support, spanning across radio, TV, and print platforms. Their invaluable assistance has not only propelled us towards achieving our financial objectives but, more significantly, has enabled us to work towards our recruitment target to enable more mentoring relationships.
